Minutes of Commission Meeting Thursday, October 27, 2022 Location: Meeting held via Zoom

The meeting was called to order at 10:02 a.m.

Probation Office Report

Request was conveyed to Probation to provide monthly statistical reports to commissioners in advance to make more efficient use of the time during meetings with the JJDPC. Would also need to post written documents in advance in keeping with Brown Act requirements.

Shean provided an update on the treatment development program at Juvenile Justice Center in preparation for the Boys Camp closure. She reiterated that three working groups were established, currently still open and meeting monthly:

- Educational & Vocational Services
- Therapeutic Services (holistic wellness), and
- Evidence-Based Practices (data-driven interventions for high-risk youth).

The plan is to reconvene in December to hear the work groups' preliminary proposals and attempt to put together a more complete plan to be offered at JJC.

Capital project updates

Work is proceeding in developing Unit 3's yard to a green space, funded by an earlier BSCC grant. Hope is to break ground in December for a half-field soccer space, pickleball court, individual workout stations and outdoor visiting area. Contracts are in place.

There is a large camera project—replacing cameras inside and outside the facility to access current blindspots and help ease viewing of videos.

Unit 1 through 3 (older part of building, currently not in use) remodel project is also proceeding, in its beginning stages. Probation met with architect and County General Services to redesign and prepare the space for the anticipated “aging” population.

Probation is moving to an electronic monitoring system for the mandatory 15-minute checks, away from current paper and pencil procedure.

Staffing change

Shean announced she will be retiring on December 9.

Restorative Justice

Barrera mentioned that funding from the three-year Youth Reinvestment Grant will be running out at the end of February; alternative funding sources are being sought. Recently launched the Restorative Justice Diversion Program through students with the Santa Barbara College of Law; the first few cases have been sent as part of a pilot program.

Questions and Comments

—Celichowski reinforced his support for the restorative justice program, as he found it to be effective in past work, especially with younger, nonviolent offenders.
